



\$10,000 Room Makeover Promotion

Official Rules

I. NAME OF PROMOTION: Bacon's Furniture \$10,000 Room Makeover Promotion (the "Promotion")

II. SPONSOR AND ADMINISTRATOR: This Promotion is sponsored and administered by Bacon's Furniture (the "Sponsor and Administrator"), located at 17701 Murdock Circle, Port Charlotte, Florida 33948.

III. ELIGIBILITY: To be eligible, entrant must be at least 18 years of age. Employees of the Sponsor and their immediate family members are not eligible. By participating in this Promotion, all entrants agree to be bound by these Official Rules and agree that decisions of the Sponsor will be valid and binding in all respects. The Sponsor is not responsible for incomplete, inaccurate or invalid entries. Copies of all entry forms submitted for verification will become the property of the Sponsor and, by completing the Promotion Registration (as defined below), all entrants consent to the limited use of information provided on the form by the Sponsor but will have the ability to opt out of any subsequent e-mail correspondence.

IV. HOW TO ENTER: No Purchase Necessary. Registration begins October 12, 2024 at 10:00 am EST and ends on December 3, 2024 at 6:00 pm EST. To enter the Promotion, consumers may complete an entry form at Bacon's Furniture during regular business hours, located at 17701 Murdock Circle, Port Charlotte, Florida 33948 ("Promotion Registration"). Upon completing the Promotion Registration, entrants will receive one (1) entry in the prize drawing. A maximum of one (1) Promotion Registration per person will be accepted. Any effort by an entrant to misrepresent themselves through the use of aliases or to misrepresent their eligibility age will disqualify that entrant.

V. WINNER SELECTION AND NOTIFICATION:

Prize Drawing: A random drawing of entries will be made on or about December 9, 2024. There will be three (3) prizes awarded – a Grand Prize, a 2nd Place Prize and a 3rd Place Prize. The potential prize winners will be notified via email, phone or both within 48 hours of the drawing. The potential prize winners will each have seven (7) calendar days to claim their respective prize by responding to the notification by the Sponsor, after which they will forfeit the prize and have no further claim to the prize. Sponsor will then award the prize to the next entrant selected in the random drawing. Prizes cannot be transferred, substituted, or redeemed for cash. Upon acceptance of the prize, the winner shall be deemed to have waived all claims against the Sponsor arising out of entry in the Promotion.

VI. Special order items currently available for purchase through the Store will be included. The Grand Prize winner will also receive in-store interior design services from Bacon's Furniture which are always complimentary. The Grand Prize winner will have until May 1, 2024 to use the gift certificate, after which the balance remaining on the gift certificate will expire. All sales tax and delivery charges on furniture items will be the sole responsibility of the Grand Prize winner. Winner will receive a Form 1099 for the value of the prize.

The **2nd Place Prize** will be a queen size Nautica Home12" 6-zone Hyacinth Air Bed with EZ Flex 230 Power Adjustable base, with a combined retail value of \$4,498. The 2nd Place Prize winner will have up to 60 days from the date of notification to claim their prize, after which it will be forfeited. The winner will be responsible for all sales tax and delivery charges, and will receive a Form 1099 for the value of the prize.

The **3rd Place Prize** will be Barcalounger Baltic II Power Swivel Recliner in the winner's choice of leather match colors, with a retail value of \$1,699. The winner will be responsible for all sales tax and delivery charges, and will receive a Form 1099 for the value of the prize.

XI. ADDITIONAL RULES AND RESTRICTIONS: By participating in this Promotion, entrants agree to abide by and be bound by the Official Rules and the decisions of the Sponsor, which shall be final in all matters relating to this Promotion. The decisions of the Sponsor, and any entity selected to represent the Sponsor regarding this promotion, are final and binding in all respects. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Promotion as solely determined by Sponsor. In the event an entrant wins a prize and is later found to be in violation of these rules he/she will be required to forfeit the prize or to reimburse Sponsor for the stated value of the prize.
